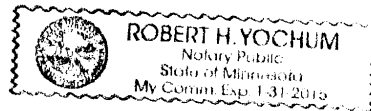

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 25th day of July, 1963, I found the Angle point 9 corner of section 17 which was evidenced by remains of the G.L.O. resurvey of 1918. corner was found to be

marked by a 1 inch diameter iron pipe with brass cap stamped
