

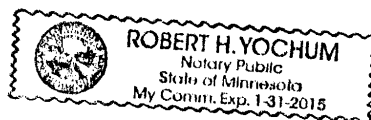

AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Quarter Corner to Sec. s 19 & 20 T. 141N R. 29W No. 490

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 22nd day of June, 1965, I found the Quarter corner of Sections 19 & 20 which was evidenced by a 1 1/4 inch pipe at old fence corner.

Note - adjoining land owner says this has been an agreed upon corner for many years. The G.L.O. found the above pipe and remains of the original SW B.T. in 1918 and accepted both as being true.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2 inch diameter 5 feet long galvanized steel pipe filled with concrete and capped with a 3 inch diameter bronze tablet stamped
