

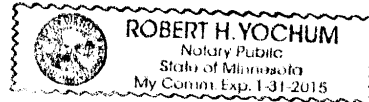

AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

East 1/16 Corner to Secs 22 & 27 T. 141N R. 29W No. 491

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 21st day of June, 1965, I found the East 1/16 corner of sections 22 & 27 which was evidenced by the remains of the G.L.O. resurvey of 1918.

Corner was marked with a 1 inch diameter iron post with brass cap marked

E 1/16 $\frac{S22}{S27}$

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No new monument set as old one is in good condition.

from which reference or witness monuments are located in the manner following:

Norway Pine 10 inch N5° E 14.7 feet scribed E 1/16 S22 BT
 Norway Pine 10 inch N35° W 39.4 feet scribed E 1/16 S22 BT

Set a steel sign post 72 inches long set 24 inches in ground with signs 54-2 & 54-4 attached, due West 6.3 feet.
