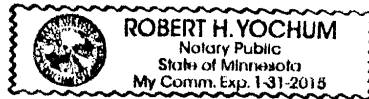

## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Angle Point #3

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 25th day of September, 1963, I found the Angle point #3 corner of Sections 2 - 35 which was evidenced by the remains of the GLO resurvey of 1917. Corner was found to be marked by a 1 inch diameter iron post with a brass tablet stamped:

S 35
AP 3
TR
1704
S 2
1917

No bearing trees were marked.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No new monument set as the GLO brass cap is in good condition.

from which reference or witness monuments are located in the manner following:

Jack pine 11 inch N13°W 8.05 Feet MKD X BT

Jack pine 7 inch S80°W 10.65 feet MKD X BT

Steel sign post 72 inches long set 24 inches in ground with standard signs 54-2 and 54-4 attached due west 4.65 feet.
