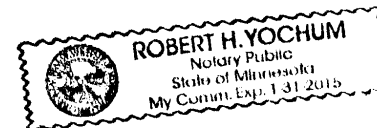

## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 5th day of August, 1968, I found the North East 1/16 corner of Section 10 which was evidenced by remains of the G.L.O. resurvey 1917 consisting of 1 inch diameter iron post 3 feet long with brass cap marked NE 1/16 S10 1917  
N. Pine 14 inch N38°E 93.06 feet - found in poor condition

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as G.L.O. monument is in good condition.
