

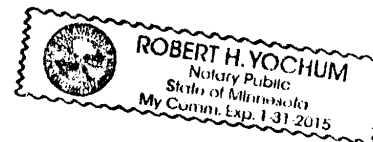

AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 19th day of February, 1963, I found the center West 1/16 corner of Section 17 which was evidenced by the remains of the G.L.O. survey of 1917. Corner was found to be marked by a 1 inch diameter iron post with a brass cap stamped:

C $\frac{W 1/16}{S 17}$ C
 1917

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as the G.L.O. brass cap is in good condition.

from which reference or witness monuments are located in the manner following:

Oak 7 inch N2°E 15.5 feet Marked C W 1/16 BT

Red pine 8 inch S55°W 54.7 feet Marked C W 1/16 BT

White pine 8 inch N80°W 66.1 feet Marked C W 1/16 BT

Steel sign post 72 inches long, set 24 inches in ground with standard signs 54-2 and 54-4 attached due south 4.1 feet.

All reference bearings are true bearings.
