## State of Minnesota, County of Cass

Peter J. Meyer , being first duly sworn, deposes and says:

That I reside at Cass Lake , Minnesota , and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 19th day of February , 19 63, I found the closing corner of the west 1/16 line section 17 I.R.B.

which was evidenced by the remains of the G.L.O. survey of 1917.

corner was found to be marked by a 1 inch diameter iron post with a brass cap stamped:

C.C.

Norway pine 8 inch S 6½°E 25¼ links (167.6¼¹)(now a 12" stub with scribe plain, at record bearing and distance).

S 17

Jack pine ¼ inch N80¼°W 1¼8 links (97.68¹)(now a 13" Jack pine at record bearing and distance with scribe visible)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permane typearker consisting of no new monument set as the G.L.O. brass cap is in good condition.

from which reference or witness monuments are located in the manner following:

Jack pine 12 inch S81°W 72.45 feet Marked BT BT

White pine 7 inch S30°E 71.8 feet Marked BT BT

Steel sign post 72 inches long, set 24 inches in ground, with standard signs 54-2 and 54-4 attached due north 4.4 feet.
