





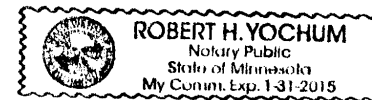

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807

I further depose and say that on the 22nd day of September, 1964, I found the Section corner of Sections 28-29-32-33 which was evidenced by remains of original Government survey of 1873.

J. Pine 13 inch S32°W 19.14 feet - now a decayed stump at record bearing and distance.  
J. Pine 16 inch N51°W 21.12 feet - now a pine stump with BT visible at record bearing and distance.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2 inch diameter 5 feet long galvanized steel pipe filled with concrete and capped with a 3 inch diameter bronze tablet stamped.
