

## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

William H. Okerman, being first duly sworn, deposes and says:  
That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.  
I further depose and say that on the 2nd day of October, 1964, I found the Quarter corner of Section's 31 - 36 which was evidenced by remains of a Cass County survey which was a 2 inch diameter iron pipe.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2 inch inside diameter 5 foot long galvanized steel pipe filled with concrete and capped with a 3 inch diameter bronze tablet stamped:

S36 | S31  
1965
