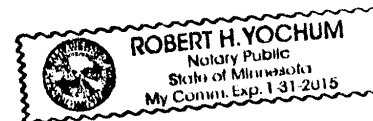

## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

being first duly sworn, deposes and says:  
 That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 9th day of July, 1962, I found the Quarter corner of Sections 6-31 which was evidenced by a 2" x 48" iron pipe set by Cass County Surveyor John Curo in 1916.

Notes of this survey are found in Cass County Record Book "C" page 113.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2" inside diameter, 5' Long galvanized wrought iron pipe filled with

concrete and capped with a 3" diameter bronze tablet stamped: - T 142 N R 31W
