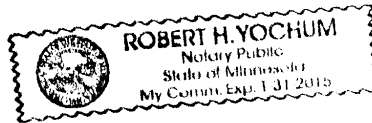

## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 21st day of May, 1962, I found the Center East 1/16 corner of Section 7 which was evidenced by a 2" inside diameter capped iron pipe set by Cass County Surveyor John Curo in 1915. A plat of his survey is filed in the Cass County Courthouse.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 6" diameter, 5' long cylindrical concrete monument capped with a 3" diameter bronze tablet stamped:-
