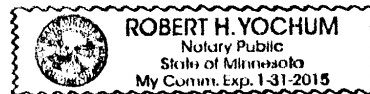

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

I further depose and say that on the 23rd day of April, 1962, I found the Quarter corner of Sections 11 - 12

which was evidenced by remains of original Government bearing trees from survey of 1873.

Norway Pine stump 20" S26°E 14 links (9.24')

Norway Pine stump 28" S26°W 20 links (13.20')

Corner was found to be marked by a 1 inch diameter iron post with brass cap stamped: $\frac{1}{4}$
 Set by G.L.O. resurvey of 1917. Also two G.L.O. BTs S11|S12
 Tamarack 6" S58 $\frac{1}{2}$ °E 172 links (113.52') (Now 12" tamarack S60 $\frac{1}{2}$ °E 114.52' scribe 1917
 overgrown.

Oak 5" N42°15'W 162 links (106.92') Now 12" Oak N44°W 107.92' scribe overgrown.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No new marker set as G.L.O. brass cap is in place.
