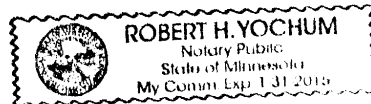

Peter J. Meyer, being first duly sworn, deposes and says:
 That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628
 I further depose and say that on the 23rd day of April, 1962,
 I found the Center South 1/16 corner of Section 12
 which was evidenced by remains of the G.L.O. survey of 1917
 Iron post 3 feet long 1 inch diameter with brass cap marked:-
 (Found iron post with brass cap alongside a "T" fence corner) S 1/16 S12
 Oak 9" N27°E 289 links (190.74') (Now 13" oak with dim scribe visible N27°E 190.74') 1917
 Oak 12" S82 1/4°W 131 links (86.46') (Now oak snag mostly decayed S82 1/4°W 86.46')

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as G.L.O. brass cap is in place.
