





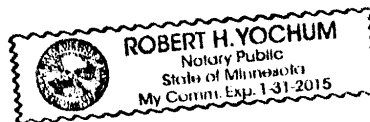

## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 20th day of February, 1963, I found the North East 1/16 corner of Section 17

which was evidenced by the remains of the G.L.O. survey of 1917  
Corner was found to be marked by a 1 inch diameter iron post with a brass cap stamped:Norway pine 12" N25½°E 35 links (23.10')(now a 12 inch pine NE 1/16 S 17  
windfall at record bearing and distance with scribe partly visible). 1917Norway pine 12" S43°E 17 links (11.22')(now a 19 inch red pine at record bearing  
and distance with scribe overgrown)and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker  
consisting of no new monument set as the G.L.O. brass cap is in good condition.

from which reference or witness monuments are located in the manner following:

Red pine 19 inch S43°E 11.22 feet re-scribed NE 1/16 BT

White pine 25 inch S36°W 29.0 feet scribed NE 1/16 BT

Steel sign post 72 inches long, set 24 inches in ground, with standard  
signs 54-2 and 54-4 attached due West 3.75 feet.

All reference bearings are true bearings.
