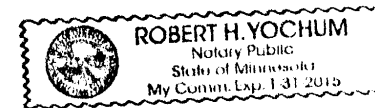

Peter J. Meyer, being first duly sworn, deposes and says:

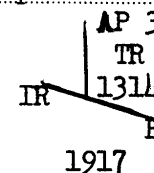
That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 21th day of April, 1962, I found the Indian Reservation/ Boundary corner of Sections 13 - 14 which was evidenced by an iron post 3 feet long, 1 inch diameter with brass cap marked:

Set by G.L.O. survey of 1917.

Cedar 8" N51°E 85 links (56.10') (Now a down stub N51°E 56.10')

Pine 14" S87 1/2°W 186 links (122.76') (Now a pine windfall with a few scribe marks visible)



and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No new monument set as G.L.O. brass cap is in place.

from which reference or witness monuments are located in the manner following:

Cedar 9" N72 1/2°E 97.2 feet marked X BT

Tamarack 11" S41°W 73.5 feet marked X BT

Cedar post 4" x 4" x 72" penta-treated with red top N 5°E 2.0 feet
