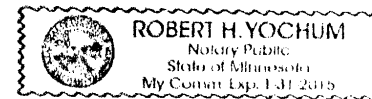

....., being first duly sworn, deposes and says:
 That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 17th day of July, 1962, I found the East 1/16 corner of Sections 18-19 which was evidenced by a 1 3/4" diameter iron pipe 48" long set by Cass County Surveyor John Guro in 1915. A plat of his survey is filed in Cass County Courthouse.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2" inside diameter 5' long galvanized wrought iron filled with concrete

and capped with a 3" diameter bronze tablet stamped: - T 141N R 31W
