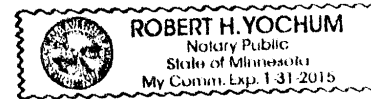

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 13th day of September, 1962, I found the section corner of sections 13, 14, 23, 24 which was evidenced by a 2" diameter 4 foot long iron monument set by Cass County Surveyor John Curo in 1911, notes of this survey found in County record book A page 386. This pipe was found buried under old road.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 6 inch diameter, 24 inch long cylindrical concrete monument capped with a 3 inch diameter bronze tablet stamped:-
