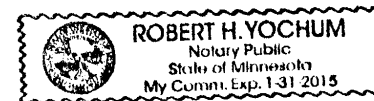

....., being first duly sworn, deposes and says:
 That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 25th day of May, 1962, I found the North East 1/16 corner of Section 31 which was evidenced by a 1 3/4" inside diameter iron pipe set by Cass County Surveyor

E. B. Horst in 1921. Notes of survey found in County Record Book "C" page 446.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 6" diameter, 5 foot long cylindrical concrete monument capped with a

3" diameter bronze tablet stamped: -
