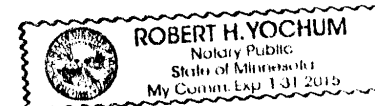

## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 26th day of June, 1962, I found the North 1/16 corner of Sections 33 - 34 which was evidenced by a 2" x 48" iron pipe set by Cass County Surveyor John M. Greene in 1928. A plat of this survey is filed in Cass County Courthouse,

Iron monument (Found a 2" outside diameter iron pipe marking corner.)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2" inside diameter, 5 foot long galvanized wrought iron pipe filled with concrete and capped with a 3" diameter bronze tablet stamped:-
