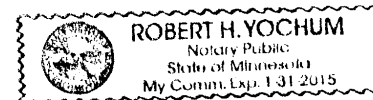

AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 25th day of May, 1962, I found the Center East 1/16 corner of Section 31 which was evidenced by a 1 3/4" diameter iron pipe set by Cass County Surveyor E. B. Horst in 1921. Notes of his survey found in County Record Book "C" page 446.

The iron pipe was found alongside a fence corner estimated to be 30 years old.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2" inside diameter 5' Long galvanized wrought iron pipe filled with concrete

and capped with a 3" diameter bronze tablet stamped: -
