

, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

I further depose and say that on the 18th day of July, 1962, I found the Special Meander corner of Section 31 which was evidenced by an iron pipe set by Cass County Surveyor E. B. Horst in 1921.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2" inside diameter, 5' long galvanized wrought iron pipe filled with concrete and capped with a 3" diameter bronze tablet stamped:

1962
PLS No. 3628

Red Pine 15" N52°E 43.5' MKD SMC BT





