Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

I further depose and say that on the 7th day of January, 1963, I found the West 1/16 corner of sections 21 - 28

which was evidenced by the remains of a survey by the General Land Office in 1926.

Found a 1 inch diameter iron post with brass cap stamped W1/16 $\frac{S21}{S28}$

Maple 6 inch N42 $\frac{1}{2}$ °E 26 links or 17.16 feet (now a 10 inch 1926
 Maple N42°E 15.35 feet with scribe overgrown.)

Maple 6 inch S20°E 6 links or 3.96 feet (now a 8 inch maple S17°E 3.96 feet with
 scribe overgrown.)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as the G.L.O. brass cap is in good condition.
