



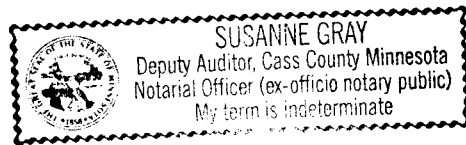

Peter J. Meyer , being first duly sworn, deposes and says:

That I reside at Cass Lake , Minnesota , and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.....

I further depose and say that on the 10th day of January , 1963..... , I found the north 1/16 corner of sections 28 - 29

which was evidenced by the remains of a General Land Office survey of 1926

Found - a 1 inch diameter iron post with brass cap stamped -	N 1/16
Poplar 8 inch S80°E 52 links or 34.32 feet (now a 11 inch	S 29 S 28
aspensnag S82°E 34.9 feet with scribe overgrown.)	1926
Poplar 10 inch S52°W 95 links or 62.7 feet (now a 13 inch aspen	
S50°W 62.7 feet with scribe overgrown.)	

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as the G.L.O. brass cap is in good condition.
