



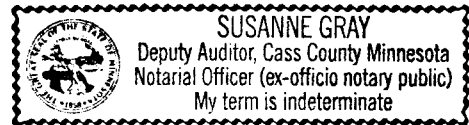

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

I further depose and say that on the 4th day of January, 1963, I found the north east 1/16 corner of section 28

which was evidenced by a 1 inch diameter iron post with a brass cap stamped:— NE 1/16 S28 1926

Cedar 7 inch N50°W 4 links or 2.64 feet (now a 11 inch cedar N70°W 3.2 feet scribed NE 1/16 S 28 BT.)

Birch 6 inch S22°E 10 links or 6.6 feet (now a birch stump S22°E 6.6 feet with scar facing corner.)

The above evidence is from a G.L.O. survey of 1926.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as the G.L.O. brass cap is in good condition.

from which reference or witness monuments are located in the manner following:

Cedar 16 inch N33¹/₂°W 37.35 feet marked N.E 1/16 S 28 BT

Cedar 12 inch N63°E 32.35 feet marked N E 1/16 S28 BT

Steel sign post 72 inches long set 24 inches in ground with signs 54-2 and 54-4 attached Due East 4.78 feet.
