



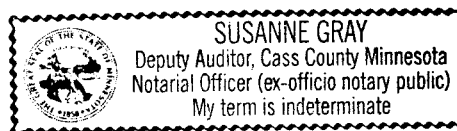

being first duly sworn, deposes and says:
 That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628
 I further depose and say that on the 20th day of September, 1962,
 I found the Meander corner of Sections 30-31
 which was evidenced by two bearing trees of G.L.O. resurvey of 1926

Cedar 14" N 38°E 11 Lks or 7.26 feet (Now a 18" cedar N 38°E 35.64 feet with scribing visible).
 Birch 10" S 18°E 54 Lks or 35.64 feet (Now a 11" birch stub S 18°E 7.26 feet with scribing visible).

Corner was found to be marked by a 1 inch diameter iron post with brass cap stamped:

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No new monument set as iron post with brass cap is in good condition.
