That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 20th day of September, 1962, I found the South West 1/16 corner of Section 31

which was evidenced by two bearing trees from the G.L.O. survey of 1926

Elm 6" N 4°W 16 Lks or 10.56 feet (Now a 13" Ash N 3°W 11.0 feet with scribe overgrown.)

Basswood 8" S 5°W 15 Lks or 9.90 feet (Now a 14" Basswood, center decayed S 5°W 9.9 feet)

Corner was found to be marked by G.L.O. iron post with brass cap stamped: -
