That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.
I further depose and say that on the 3rd day of December, 1965, I found the Center South 1/16 corner of Section 31 which was evidenced by remains of the G.L.O. resurvey of 1926
