



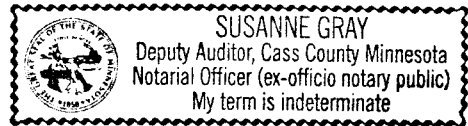

## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807

I further depose and say that on the 2nd day of June, 1964, I found the Northeast 1/16 corner of section 8 which was evidenced by 1" iron pipe set by Chippewa National Forest Engineer Meyer in 1956

and verified by survey

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of 2 inch inside diameter 60 inch long galvanized steel monument filled with

concrete and capped with a 3 inch diameter bronze tablet marked

T144N R27W

1964

RLS No. 6807

from which reference or witness monuments are located in the manner following:
