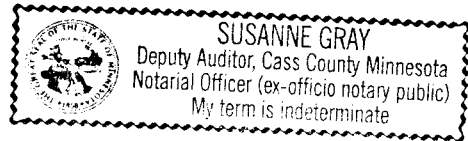

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 14th day of June, 1966, I found the Quarter corner of Sections 9-10 which was evidenced by G.L.O. resurvey of 1937

a set iron post 3 feet long by 1 inch in diameter with brass cap marked
White Pine 30 inch S80°E 10 links or 6.60 feet - Now a rotted stump at correct bearing and distance - scribe visible.
