



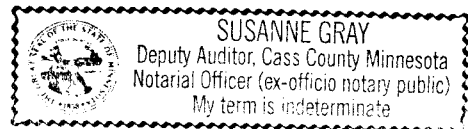

William H. Okerman, being first duly sworn, deposes and says:
That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.
I further depose and say that on the 16th day of June, 1966, I found the Quarter corner of Section's 18-17 which was evidenced by G.L.O. resurvey of 1937 a set iron post 3 feet long 1 inch diameter with brass cap marked
Norway Pine 23 inch N75¹/₂⁰E 202 links or 133.32 feet - Now a pine blow down at correct bearing and distance. S18 1/4 S17 1937
Norway Pine 18 inch N27¹/₂⁰W 117 links or 77.22 feet - Now a pine snag N30⁰W 84.4 feet - scribed visible.
and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new marker set, used G.L.O. brass cap.

from which reference or witness monuments are located in the manner following:

Oak 4 inch N78⁰E 53.15 feet - scribed 1/4 S17 BT.

Elm 5 inch N40⁰W 52.9 feet - scribed 1/4 S18 BT.

Set a steel sign post 72 inches long with signs 54-2 and 54-4 attached due North 4.2 feet.

All reference bearings are true bearings.
