



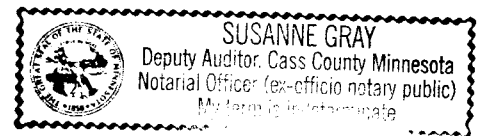

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 23rd day of June, 1966, I found the Quarter corner of Section's 24 - 19

which was evidenced by G.L.O. resurvey of 1937 a set iron post 3 feet long by 1 inch in diameter with brass cap marked: 1/4

White Pine 6 inch N57°E 10 lks or 6.60 feet - Now a 12 inch White Pine at correct bearing and distance - blaze visible. S24 | S19

Cedar 6 inch S19 1/2°W 39 lks or 25.74 feet - Now a 11 inch Cedar at correct bearing and distance - scribe visible. 1937

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No new marker set, used G.L.O. brass cap

from which reference or witness monuments are located in the manner following:

G.L.O. White Pine 12 inch N57°E 6.60 feet - rescribed 1/4 S19 BT.

Set a steel sign post 72 inches long with signs 54-4 and 54-2 attached due West 4.7 feet.

All reference bearings are true bearings.
