That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 23rd day of August, 1968, I found the Quarter corner of Sections 8-17 which was evidenced by remains of the original Government survey of 1872
