That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 15th day of October, 1968, I found the Quarter corner of Sections 20-29 which was evidenced by Cass County survey of 1919 by James H. Flynn. Set iron monument - found in place

Elm 8 inch N58°W 28.5 feet - now 15 inch at record bearing and distance

Elm 6 inch S44°W 35.0 feet - now 10 inch at record bearing and distance

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of 2 inch diameter 5 foot long steel pipe filled with concrete and capped with a bronze tablet stamped
