William H. Okerman, being first duly sworn, deposes and says:
That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.
I further depose and say that on the 11th day of November, 1963, I found the 1/4 corner of Sections 29 & 32 which was evidenced by remains of the original Government survey of 1872
Cedar 12" S9°E 5 lks (3.3') Found decayed stump at record bearing and distance
Cedar 14" N28°W 15 lks (9.9') Found decayed stump at record bearing and distance
Found squared, scribed post marking corner (possible original) - also a 1" iron pipe

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of 6" diameter 60" long cylindrical concrete monument capped with a 3" diameter bronze tablet stamped:
