## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

I further depose and say that on the 15th day of May, 1963, I found the Quarter corner of sections 9 - 10 which was evidenced by two remaining bearing trees from the original Government survey of 1873.

Norway pine 14 inch S65°E 12 links (7.92 feet) (Now a 18 inch pine windfall S65°E 7.92 feet scribed "¼ S BT".

Norway pine 15 inch S47°W 23 links (15.18 feet) (Now a pine windfall partly decayed S47°W 15.18 feet.)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2 inch inside diameter, 5 foot long, galvanized wrought iron pipe filled with concrete and capped with a 3 inch diameter bronze tablet stamped:-

from which reference or witness monuments are located in the manner following:

White pine 11 inch N11°E 14.5 feet marked ¼ BT

White pine 8 inch S52°E 9.65 feet marked ¼ BT

Steel sign post 72 inches long, set 24 inches in ground with signs 54-4 attached S32½°W 4.8 feet.
