



AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 26th day of November, 1958, I found the 1/4 corner of sections 26-27 which was evidenced by two remaining original scribed bearing trees of the Government Survey of 1873.

1. 10 inch Jack Pine (now 12 inch stump partly decayed with scribing B.T. visible) N65°E, 35 links, or 23.1 feet.
2. 4 inch Jack Pine (now stump hole) S81°W, 10 links or 6.6 feet.

A check showed no evidence of the original government corner.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2 inch diameter, concrete filled pipe capped with stamped bronze marker.
