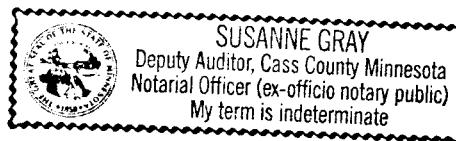

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 7th day of December, 1965, I found the Closing corner of Sections 3-4 which was evidenced by remains of the original government survey of 1873.

Norway Pine 10 inch S18°W 26.40 feet (now a 28 inch S18°W 26.40 feet scribing visible).

Norway Pine 8 inch S9°E 75.90 feet (now a 27 inch S9°E 75.90 feet scribing visible).

Post (now a decayed post in mound of stone)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2 inch inside diameter 5 foot long galvanized steel monument filled with concrete and capped with a 3 inch diameter tablet stamped
