William H. Okerman, being first duly sworn, deposes and says:
That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.
I further depose and say that on the 25th day of November, 1966, I found the Section corner of Sections 16-17-20-21 which was evidenced by remains of the G.L.O. resurvey of 1930 consisting of 2 inch diameter cylindrical concrete monument, 3 feet long with a 3 inch diameter bronze tablet stamped:
Found Monument as described. T147N R30W
Maple 14 inch N25°E 46.20 feet - now 14 inch at record bearing and distance with scribe visible. S17 S16
Maple 12 inch S79°E 55.44 feet - now 15 inch at record bearing and distance with scribe overgrown. S20 S21
Maple 8 inch S66°W 28.38 feet - now 10 inch at record bearing and distance with scribe overgrown. 1930
Basswood 8 inch N50°W 21.78 feet - not found.
and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as G.L.O. monument is in good condition.
