





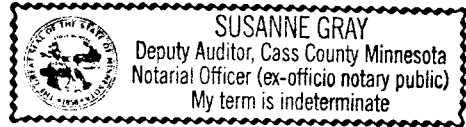

## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

I further depose and say that on the 18th day of February, 1963, I found the Center South 1/16 corner of Section 11

which was evidenced by the remains of the GIO survey of 1926

Corner was found to be marked by a 1 inch diameter iron post with brass cap stamped:

Cedar stump 12" N1½°E 24 lks. (15.84') (Now a 12" cedar stump N1½°E 15.84 feet.)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No. new monument set as the GIO brass cap is in good condition.

Ash 3 inch S28°E 13.55 feet marked X BT

Ash 6 inch N 69°W 58.2 feet marked CS 1/16 BT

Elm 4 inch N 43°W 61.9 feet marked X BT

Steel sign post 72 inches long, set 24 inches in ground with standard signs 54-2 and 54-4 attached due North 4.9 feet.

All reference bearings are true bearings.
