AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 7th day of March, 1963, I found the Center Quarter corner of Section 14 which was evidenced by the remains of the G.L.O. survey of 1926.

Corner was found to be marked by a 1 inch diameter iron post with brass cap stamped:-

Tamarack 8" S53° E 43 links (28.38') (Now a tamarack stump scribed "BT",
at record bearing and distance.) C 1/4 S14 1926

Tamarack 10" N51° W 36 links (23.76') (Now a 12" tamarack at record bearing and distance with scribe overgrown.)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as the G.L.O. brass cap is in good condition.

from which reference or witness monuments are located in the manner following:

Tamarack 7 inch S38° E 41.3 feet marked C 1/4 S14 BT

Tamarack 7 inch S51° W 18.9 feet marked C 1/4 S14 BT

Steel sign post 72" long, set 24" in ground with standard signs 54-2 and 54-4 attached due North 4.25 feet.

All reference bearings are true bearings.
