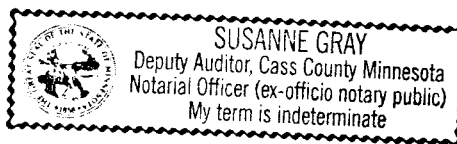

AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807

I further depose and say that on the 20th day of August, 1964, I found the Center East 1/16 corner of Section 14 which was evidenced by remains of the G.L.O. resurvey of 1926. Found brass cap in place but bent over. Could not restore it, so replaced it with a new monument.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 6 inch diameter, 5 foot long cylindrical concrete monument, capped with a 3" diameter bronze tablet stamped:-

 RLS No. 6807

from which reference or witness monuments are located in the manner following:

Elm 11" S59°W 11.7 feet scribed CE 1/16 S 14 BT

Steel sign post 72" long set 24" in ground with signs 54-2 and 54-4 attached due North 4.35 feet.

All reference bearings are true bearings.
