, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 8th day of March, 1963, I found the Northwest 1/16 corner of section 23 which was evidenced by the remains of the G.L.O. survey of 1926. Corner was found to be marked by a 1 inch diameter iron post with a brass cap stamped

NW 1/16 S23
 1926

White Pine 6 inch S66½°E 18 links (11.88') (now a 11" White Pine at record bearing and distance with scribe "NW 1/16 S23" visible.)

Tamarack 14" N5°W 26 links (17.16') (now a Tamarack stump N5°W 17.16 feet with scribe "NW 1/16 S" visible.) and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No. new monument set as the G.L.O. brass cap is in good condition.
