



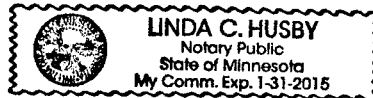

William H. Okerman, being first duly sworn, deposes and says:
That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.
I further depose and say that on the 7th day of July, 1969, I found the South Quarter corner of Section 36 which was evidenced by remains of the original Government survey of 1875.
N. Pine 30 inch N50°W 19.14 feet - found stump and blaze where BT was scribed at record bearing and distance.
N. Pine 30 inch N80°E 99.66 feet - found stump at record bearing and distance, has been hit by dozer blade.

Found G.L.O. brass cap marked:

S. C.
 $\frac{1}{4}$ S36
1930

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as G.L.O. monument is in good condition.
