Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

I further depose and say that on the 15th day of May, 1962, I found the East 1/16 corner of Sections 26 - 35 which was evidenced by an oak post and one bearing tree from a survey by registered Land Surveyor J. A. Gjelhaug in 1937, a plat of his survey is filed in the Forest Supervisor's Office, Chippewa National Forest, Cass Lake, Minnesota. Norway Pine 18" N78 1/2°E 52 links (34.32') (Now a 23" Norway Pine stump with scribe "S BT" visible N78 1/2°E 34.32'). Corner was found to be marked by a squared scribed oak post.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 6" diameter 5' long cylindrical concrete monument capped with a 3" diameter bronze tablet stamped:
