



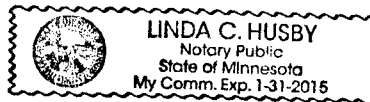

 That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807
 I further depose and say that on the 26th day of December, 1963, I found the quarter corner of Sections 12 - 13 which was evidenced by a monument set by G.L.O. in 1933 is an iron post 3' x 1" 27" in ground with a brass cap stamped:
 N. Pine 11" N. 49 3/4° W. 71 links (46.86') (now a 17" R. Pine at record bearing and distance scribe B.T. visible) S.12
 N. Pine 11' S. 45 3/4° E. 82 links (54.12') (now a 19" R. Pine at record bearing and distance with scribe overgrown.) S.13

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument was set as G.L.O. brass is in good condition.
