That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 14th day of May, 1966, I found the North East 1/16 corner of Section 13

which was evidenced by G.L.O. survey in 1933

a set iron post 3 feet by 1 inch in diameter with brass cap marked NE 1/16 S13 1933

Jack Pine 3 inch S19 1/2° E 18 lks or 11.88 feet - Now a cut off stump at bearing and distance.

Norway Pine 1 1/4 inch N78 1/2° W 189 lks or 124.74 feet - Now a 19 inch N78° W 124.74 feet - scribe overgrown.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No marker set, used G.L.O. brass cap
