



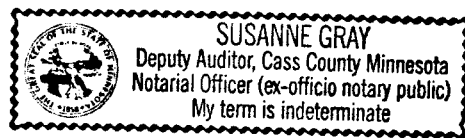

 That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.
 I further depose and say that on the 9th day of January, 1963,
 I found the quarter corner of sections 17 - 20
 which was evidenced by the remains of a survey by the General Land Office in 1926.
 Found a 1 inch diameter iron post with brass cap stamped $\frac{1}{4}$ S17 marking corner.

 1926
 Cedar 7 inch N66°15'E 41 links or 27.06 feet (now a
 9 inch cedar N66°E 27.06 feet scribed $\frac{1}{4}$ S17 BT.)
