Peter J. Meyer, being first duly sworn, deposes and says:
 That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.
 I further depose and say that on the 7th day of March, 1963, I found the section corner of 14-15-22-23 which was evidenced by the remains of the G.L.O. resurvey of 1926. The corner was found to be marked by a 2 inch diameter iron post with a brass cap stamped:-
