That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 26th day of May, 1966, I found the Quarter corner of Sections 17-20 which was evidenced by G.L.O. survey of 1933 a set iron post 3 feet long by 2 inches in diameter with brass cap stamped

Norway Pine 8 inch N1^oW 12 lks or 7.92 feet - Now a 13 inch N1^oW 7.92 feet - scribe visible. S17
