



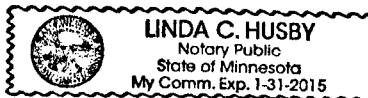

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minn., and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

I further depose and say that on the 16th day of January, 1962, I found the Quarter corner of Sections 23-26

which was evidenced by an iron post 3 feet long 1 in. diameter with brass cap marked:

Jack Pine, 12 inch N16 $\frac{1}{2}$ ⁰W 30 lks or 19.80 feet (Now a 14 inch Jack Pine
 N16 $\frac{1}{2}$ ⁰W 19.80 feet marked $\frac{1}{4}$ S23 B.T.)

Elm. 6 inch S33⁰E 48 lks or 31.68 feet (Now a 10 inch Elm bulldozed down
 S-E 32 feet.)

The iron post and bearing trees were set by G.L.O. Resurvey of 1933.
 A copy of the resurvey notes are on file in the State Capitol, St. Paul, Minn.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new marker was set, used G.L.O. brass cap as corner.
